I am sending this letter of opposition anonymously in fear of retaliation by the Monterrosa family. Opposition to Renaming Park Street to Sean Monterossa Boulevard.

Dear City Supervisors,

As a long-standing resident of Park Street, I feel compelled to express my strong opposition to the proposed renaming of our beloved thoroughfare to Sean Monterossa Boulevard. While I understand the desire to honor individuals within our community, I must vehemently advocate against immortalizing someone with a history of criminal activity and gang affiliation.

Our neighborhood has unfortunately grappled with ongoing gang violence and territory wars, exacerbating tensions and compromising the safety of our residents. It is not uncommon to routinely hear the alarming sound of guns going off, and crime has regrettably become commonplace in our daily lives.

In such a delicate environment, it is crucial to foster a sense of stability and security, which renaming our street after a known gang member would undoubtedly undermine. My family has lived in Bernal Heights for 40 years. We pay my taxes and we vote in every election. We very much oppose the petition to renamed Park Street to Sean Monterossa Boulevard.

We were sitting at the kitchen table one day and gunshots rang out. Apparently, the shots were fired by gang members. We then observed bullet holes in the driver-side door of a car we were told belonged to Sean Monterossa. The car was parked immediately outside a public elementary school. We don't want to invite this kind of serious trouble or any other problems to our neighborhood.

The location where the shooting occurred has become a focus point for drinking and litter. This contrasts with efforts underway across San Francisco to help clean up and lift up our city. The name Park Street fits with that effort and is a long-standing part of the identity of our neighborhood. Park Street is a nice street that leads to our neighborhood park. Our family, and a lot of others from our neighborhood, support and utilize Bernal Park.

I am writing to express my concerns regarding File No. 240135, which proposes renaming the intersection of Holly Park Circle to "Sean Monterrosa Boulevard."

While I understand the desire to honor Sean Monterrosa, I believe there are other ways to recognize his life without renaming a street. My primary concern is the potential impact on the immediate neighborhood.

Here are some specific observations that raise concerns for me:

- **Unruly behavior:** Some disruptive behavior occurred during past parades.
- **Feeling of intimidation:** An elderly resident expressed feeling pressured during a community event.
- **Parking issues:** The ongoing use of a resident's driveway creates inconvenience; this is part of the unruly behavior I have observed.
