3 **Ordinance authorizing settlement of the lawsuits filed by Microsoft Corporation and**  
4 **Subsidiaries against the City and County of San Francisco for \$6,500,000; the lawsuits**  
5 **were filed on February 26, 2021, April 23, 2021, and June 3, 2025, in San Francisco**  
6 **Superior Court, Case Nos. CGC-21-590032, CGC-21-591004, and CGC-25-625880;**  
7 **entitled Microsoft Corporation and Subsidiaries. v. City and County of San Francisco**  
8 **et al.; the lawsuits involve a refund of gross receipts and homelessness gross receipts**  
9 **taxes; other material terms of the settlement relate to Microsoft Corporation's filing**  
10 **position with respect to City taxes.**

12       Be it ordained by the People of the City and County of San Francisco:

13       Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
14 authorizes the City Attorney to settle the actions entitled Microsoft Corporation and  
15 Subsidiaries. v. City and County of San Francisco et al., San Francisco Superior Court, Case  
16 Nos. CGC-21-590032, CGC-21-591004, and CGC-25-625880, by the payment of \$6,500,000  
17 and the parties' agreement on Microsoft Corporation's filing position with respect to City taxes.  
18 The lawsuits involve a refund of gross receipts and homelessness gross receipts taxes.

20       Section 2. The above-named actions were filed in San Francisco Superior Court on  
21 February 26, 2021, April 23, 2021, and June 3, 2025, and the following parties were named in  
22 the lawsuit: Plaintiff Microsoft Corporation and Subsidiaries and defendant City and County of  
23 San Francisco.
