Description of Amount of Contract	Management Agreement payment terms were based on a tiered revenue sharing program based on annual gross tariff revenues generated at the facility, and a \$50,000 monthly management fee paid by the Port to Pasha. This legislation will discontinue the \$50,0000 month management fee paid by the Port.
Contract Description	Amendment to Management Agreement with Pasha Automotive Services established on July 1, 2016, giving Pasha the exclusive right to provide services to marine terminal users at the Pier 80 Terminal for a fifteen (15) year term with the option to extend the Agreement for two (2) additional successive five (5) year periods. The amendment will discontinue a \$50,000 monthly Management Fee paid by the Port to Pasha resulting in \$600K for the Port, adopt revised revenue sharing and special event provisions to allow for events like the Portola Music Festival, and restructure Pasha's exclusive use of the Port's Pier 80 terminal.
