11 WHEREAS, in January 2004, Mr. Galloway founded the RESPECT Unity Coalition
12 Party for equality, peace, the environment and genuine trade unionism; and

13 WHEREAS, Mr. Galloway recently electrified the U.S. with his appearance at a Senate
14 Permanent Subcommittee on Investigations to condemn the war in Iraq; and,

15 WHEREAS, Mr. Galloway is in the United States on a North American speaking Tour
16 entitled: Stand Up And Be Counted, promoting his new book "Galloway Goes to Washington"
17 and advocating for Peace in Iraq; and,

18 WHEREAS, Mr. Galloway will be in San Francisco on September 21st as part of his
19 national tour; and

20 WHEREAS, 63% of San Francisco voters have approved Proposition N, a declaration
21 of City policy urging the United States government to cease hostilities in Iraq and bring all
22 military personnel in Iraq back to the United States; now, therefore, be it

23 **RESOLVED, That Board of Supervisors of the City and County of San Francisco hereby**
24 **commends George Galloway for his efforts to promote peace in Iraq through his "Stand Up**
25 **and Be Counted" tour.**






