

EXECUTIVE SUMMARY	
Legislative Objective	
<p>The proposed ordinance would (a) de-appropriate \$320,000 of salaries in the Public Utilities Commission's FY 2011-12 operating budget, and (b) re-appropriate the \$320,000 for Overtime in the Public Utilities Commission's FY 2011-12 budget in order to resolve the Department's projected budgetary shortfall in Overtime as required per Administrative Code Section 3.17. The proposed ordinance would re-appropriate (a) \$250,000 for Overtime in the Clean Water Department (Wastewater Enterprise) and (b) \$70,000 for Overtime in the Hetch Hetchy Water and Power Department (Hetchy Water Division).</p>

<ul style="list-style-type: none"> • Administrative Code Section 3.17, which was approved by the Board of Supervisors in September of 2011, requires that the Annual Appropriation Ordinance contain a separate Overtime appropriation for the Public Utilities Commission (PUC), and the PUC must request a supplemental appropriation ordinance, subject to Board of Supervisors approval, if their Overtime expenditures are proposed to be greater than the amount of overtime appropriated in the Annual Appropriation Ordinance. • The FY 2011-12 approved budget for the PUC includes \$1,300,976 in Overtime expenditures for the Wastewater Enterprise and \$777,906 in Overtime expenditures for the Hetchy Water Division. • The three primary reasons for the requested additional Overtime expenditures for the Wastewater Enterprise are unanticipated staff coverage for (a) the 49ers National Football Conference Championship Game, (b) Islais Creek- Selby-Marin Outfalls Facility, and (c) ongoing staffing issues of vacant permanent positions, coupled with delays in permanent position hiring. • The three primary reasons for the requested additional Overtime expenditures for the Hetchy Water Division are (a) strict scheduling requirements included in the City's labor agreement with Local 6, International Brotherhood of Electrical Workers, (b) critical staffing shortages in the power generation classifications, and (c) several ongoing special projects and related regulatory requirements.

<ul style="list-style-type: none"> • Of the total requested additional \$320,000 of Overtime expenditures, the Wastewater Enterprise's requested \$250,000 re-appropriation would increase Overtime from \$1,300,976 to \$1,550,976, an increase of 19.2 percent; and the Hetchy Water Division's requested re-appropriation of \$70,000 would increase Overtime from \$777,906 to \$847,960, an increase of 9.0 percent. 	

- Based on the Budget and Legislative Analyst’s projections for FY 2011-12, the PUC is estimated to need an additional (a) \$1,571,616 for the Wastewater Enterprise, which is \$20,640 more than the \$1,550,976 request, and (b) an additional \$834,731 for the Hetchy Water Division, which is \$13,175 less than the \$847,906 request. However, according to the PUC, it will need the entire requested \$320,000 to manage its budget for the balance of FY 2011-12. The Budget and Legislative Analyst concurs.

MANDATE STATEMENT / BACKGROUND

Mandate Statement

Charter Section 9.105 requires that amendments to the Annual Appropriation Ordinance be subject to approval by ordinance of the Board of Supervisors, after Controller certifies the availability of funds.

Administrative Code Section 3.17, which was approved by the Board of Supervisors in September of 2011, requires that the Annual Appropriation Ordinance contain a separate Overtime appropriation within the Airport, Emergency Management, Police, Public Health, Public Utilities, and Public Works, Recreation and Park and Sheriff Departments’ operating budgets. In accordance with Administrative Code Section 3.17(b), these eight identified City departments must also request a supplemental appropriation ordinance, which is subject to Board of Supervisors approval, if their Overtime expenditures are proposed to be greater than the amount of Overtime appropriated in the Annual Appropriation Ordinance.

Background

Table 1 below shows the Public Utilities Commission’s (PUC) actual Overtime expenditures for FY 2010-11 and the approved Overtime budget appropriations for FY 2011-12, for the Clean Water Department (Wastewater Enterprise) and Hetch Hetchy Water and Power Department (Hetchy Water Division). As shown in Table 1 below, the FY 2011-12 approved budget for the PUC includes \$1,300,976 in Overtime expenditures for the Wastewater Enterprise and \$777,906 in Overtime expenditures for the Hetchy Water Division.

DETAILS OF PROPOSED LEGISLATION

The proposed ordinance would (a) de-appropriate \$320,000 of Permanent Salaries in the PUC's FY 2011-12 budget, and (b) re-appropriate the \$320,000 for Overtime in the PUC's FY 2011-12 budget in order to resolve the PUC's projected FY 2011-12 budgetary shortfall in Overtime as required per Administrative Code Section 3.17. The \$320,000 de-appropriation and re-appropriation consist of (a) \$250,000 for the PUC's Wastewater Enterprise and (b) \$70,000 for the PUC's Hetchy Water Division as shown in Table 2 below.

As shown in Table 2 above, the PUC's requested \$250,000 re-appropriation would result in a 19.2 increase in Overtime expenditures for the Wastewater Enterprise, and the requested re-appropriation of \$70,000 would result in a 9.0 percent increase in Overtime expenditure for the Hetchy Water Division.

FISCAL IMPACTS

As shown in Table 3 below, in FY 2011-12, \$1,300,976 was appropriated for Overtime expenditures PUC's Wastewater Enterprise and \$777,906 was appropriated for Overtime expenditures for Hetchy Water Division. As of March 30, 2012, PUC's Wastewater Enterprise's actual Overtime expenditures incurred were \$1,120,002 (86.1 percent), which for the remainder of FY 2011-12 leaves a balance of \$180,974 (\$1,300,976 less \$1,120,002). Hetchy Water Division's actual Overtime expenditures incurred were \$596,216 (76.6 percent) as of March 30, 2012, which leaves a balance of \$181,690 (\$777,906 less \$596,216) for the remainder of the current fiscal year.

Wastewater Enterprise

The proposed ordinance would re-appropriate \$250,000 of Permanent Salaries to Overtime in the Wastewater Enterprise in the FY 2011-12 budget to resolve a budgetary shortfall in Overtime. According to Mr. Carlos Jacobo, Budget Manager at the PUC, Overtime expenditures have been higher than anticipated due to the unanticipated staff coverage for (a) the 49ers National Football Conference (NFC) Championship Game, (b) Islais Creek- Selby-Marin Outfalls Facility, and (c) ongoing staffing issues of vacant permanent positions, coupled with delays in permanent position hiring.

Mr. Jacobo advises that regarding the 49ers NFC Championship Game held at Candlestick Park on January 22, 2012, the PUC Wastewater Enterprise incurred additional Overtime costs from January 17, 2012 through January 24, 2012, because the weather forecast for that week predicted significant rainfall, and as a result, the PUC's Department Operations Center (DOC) was activated earlier in the week prior to the NFC Championship Game. Mr. Jacobo further reports that as a result of the significant rainfall, Candlestick Park's Parking Lots were flooded the day before the NFC Championship Game, such that the Wastewater Enterprise's crews were also required to work around the clock that weekend to pump down and keep clear the parking lots for the game.

Regarding the Islais Creek- Selby-Marin Outfalls Facility, Mr. Jacobo advises that since October 2011, the Wastewater Enterprise has been trying to minimize the impact that homeless persons have on PUC facilities along the shoreline at Islais Creek, including the impacts from direct homeless encampments, copper thefts, and camp fires near PUC facility pipelines. This effort resulted in unanticipated Overtime costs that included the Wastewater Enterprise participation in several weekend work details along with the Department of Public Works, the San Francisco Police Department, the California Highway Patrol, The Garden Project, and Cal-Trans to cleanup and to keep clean the area impacted at the tip of Islais Creek.

Regarding vacant permanent staffing and delays in hiring, Mr. Jacobo advises that the Wastewater Enterprise currently has 71 vacant Full-time Equivalent (FTE) positions, and of those, 54 FTE positions need to remain vacant to achieve the budgeted FY 2011-12 salary savings. As a result, Mr. Jacobo advises that the difference of 17 vacant FTE positions (71 FTEs

less 54 FTEs) have resulted in a surplus in salaries in the Wastewater Enterprise budget that is available to be re-appropriated for the requested Overtime needs. In addition, these 17 vacant positions, coupled with hiring delays have resulted in the need for Overtime for other PUC staff in order to fill the work demands from these vacant positions. Mr. Jacobo advises that the status of the 17 FTE permanent positions are as follows: (a) seven positions are pending approval of selection of qualified applicants, (b) four positions have eligible lists of applicants based on City testing, and (c) six positions are pending lists that require the City to test potential applicants to determine the appropriate position class.

Hetchy Water Division

The proposed ordinance would also re-appropriate \$70,000 from Permanent Salaries to Overtime in the Hetchy Water Division in the FY 2011-12 budget to resolve a budgetary shortfall in Overtime. According to Mr. Jacobo, the Hetchy Water Division Overtime expenditures have been higher than budgeted due to: (a) strict scheduling requirements included in the City's labor agreement with Local 6, International Brotherhood of Electrical Workers, (b) critical staffing shortages in the power generation classifications, and (c) currently several ongoing special projects require additional Overtime and related regulatory requirements.

Mr. Jacobo reports that the City's Memorandum of Understanding (MOU) with Local 6, International Brotherhood of Electrical Workers, includes specific scheduling and staffing requirements regarding shifts and Overtime for the operation of the Moccasin, Kirkwood, and Holm powerhouses. As a result, Mr. Jacobo reports that Hetchy Water Division has little discretion regarding the staffing and scheduling of these Local 6 members outside of the specific schedules set forth in the agreement. In order to comply with the Local 6 MOU, Mr. Jacobo notes that Hetchy Water Division is required to staff each powerhouse with one 7484 Senior Power Generation Technician and two 7482 Power Generation Technician IIs and the Moccasin Powerhouse requires 24/seven coverage, and as a result, Overtime is required when an employee is sick, on vacation, or attending training. Mr. Jacobo advises that approximately \$7,000 of additional Overtime will be required in FY 2011-12 due to employee sick, vacation and training, that was not previously budgeted.

Regarding the critical staffing shortages, Mr. Jacobo advises that the Hetchy Water Division currently has five vacant FTE powerhouse positions, including: one 7482 Power Generation Technician II and four 7484 Senior Power Generation Technicians. According to Mr. Jacobo, the announcements for these vacant positions are currently in progress, such that the list for these five positions is anticipated to be issued in late April, 2012 with subsequent hiring in early May, 2012. However, Mr. Jacobo cautions that the Hetchy Water Division expects possible recruitment difficulties and limited candidates meeting the minimum requirements, such that the PUC may need to modify the minimum requirements which may result in further hiring delays. Overall, Mr. Jacobo estimates approximately \$14,000 of additional Overtime is required due to these vacant positions.

In addition to the Local 6 MOU requirements and the critical staffing shortages, Mr. Jacobo notes that Hetchy Water Division is currently conducting several ongoing special projects requiring operation support for multiple double shifts during the week that require additional

Overtime. Mr. Jacobo reports that the Hetchy Water Division was required to register as a Transmission Owner and Transmission Operator with North American Electric Reliability Corporation on July 15, 2011. According to Mr. Jacobo, this regulatory requirement increased training requirements, which can only be accommodated through Overtime due to staffing shortages in operations. Mr. Jacobo notes that failure to comply with these regulatory requirements can result in financial penalties ranging from \$10,000 to \$1,000,000 per day. Overall, Mr. Jacobo estimates approximately \$7,000 of additional Overtime is required due to these staffing shortages for special projects and \$42,000 of additional Overtime is required to address the regulatory requirements.

In total \$70,000 has been requested for additional Overtime for the Hetchy Water Division (\$7,000 plus \$14,000 plus \$7,000 plus \$42,000) as described above.

As shown in Table 3 above, as of March 30, 2012, PUC's Wastewater Enterprise's actual Overtime expenditures were \$1,120,002 and Hetchy Water Division's actual Overtime expenditures were \$596,216. Table 4 below identifies the monthly costs to date and projects the required Overtime expenditure for FY 2011-12, based on the actual expenditures incurred through March 2012.

As shown in Table 4 above, the Budget and Legislative Analyst projects a total Overtime need of \$1,571,616 for the Wastewater Enterprise, which is \$20,640 more than the \$1,550,976 total being requested. In addition, the Budget and Legislative Analyst projects a total Overtime need of \$834,731 for the Hetchy Water Division, which is \$13,175 less than the \$847,906 total being requested. However, according to Mr. Jacobo, given various additional Overtime needs between now and the end of FY 2011-12, the PUC anticipates that it will need all of the \$320,000 in requested Overtime monies in order to manage its Overtime expenditures for the balance of FY 2011-12. Based on further discussions with the PUC, the Budget and Legislative Analyst's office concurs with the PUC.

RECOMMENDATION

Approve the proposed ordinance.
