7 Be It Ordained by the People of the City and County of San Francisco:

8 **SECTION 1.** Under and pursuant to the laws of the State of California and in conformity  
9 therewith a tax is hereby levied for San Francisco Community College District purposes, for  
10 the fiscal year ending June 30, 2005, on all property, real and personal, in the City and County  
11 of San Francisco, except such property as is by law exempt from taxation, in the sum of two  
12 and six hundred eleven thousandths, nine hundred thirty-six millionths (\$0.02611936)  
13 cents on each one hundred dollars valuation of said taxable property as the same appears  
14 upon the secured assessment roll of the said City and County for said fiscal year, which said  
15 sum is hereby apportioned as follows:


