BE IT RESOLVED, That in accordance with the recommendation of the Sheriff of the City and County of San Francisco and the Director of Property, the Director of Property is hereby authorized to take all actions, on behalf of the City and County of San Francisco, as tenant, to execute a written lease (copy of which is on file with the Clerk of the Board) and other related documents with Ruth Mellinger, an unmarried woman, her successors or assigns ("Landlord"), for the building commonly known as 70 Oak Grove Street, San Francisco. California, which comprises an area of approximately 10,000 square feet on the terms and conditions herein and on a form approved by the City Attorney; and, be it

FURTHER RESOLVED, That the lease shall commence upon substantial completion of tenant improvements (expected to be about June 1, 2004) and terminate May 31, 2014. The monthly rent shall be \$14,125.00. Beginning June 1, 2009, the monthly Base Rent shall be increased by the proportional increase in the Consumer Price Index. However, in no event shall such increased Base Rent be more than \$18,362.50 nor less than \$16,243.75. The City shall pay \$132,435 for the construction of a portion of the specialty tenant improvements. The City shall pay for utilities, janitorial and other typical tenant costs including data. telecommunications and moving expenses; and, be it

FURTHER RESOLVED, That the lease shall include a clause approved by the City Attorney, indemnifying and holding harmless the Landlord, from and agreeing to defend the Landlord against any and all claims, costs and expenses, including, without limitation, reasonable attorney's fees, incurred as a result of City's use of the premises, any default by

the City in the performance of any of its obligations under the lease, or any acts or omissions of City or its agents, in, on or about the premises or the property on which the premises are located, excluding those claims, costs and expenses incurred as a result of the active gross negligence or willful misconduct of Landlord or its agents; and, be it

FURTHER RESOLVED. That all actions heretofore taken by the officers of the City with respect to such lease are hereby approved, confirmed and ratified; and, be it

FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of Property to enter into any amendments or modifications to the Lease (including without limitation, the exhibits) that the Director of Property determines, in consultation with the City Attorney, are in the best interest of the City, do not increase the rent or otherwise materially increase the obligations or liabilities of the City, are necessary or advisable to effectuate the purposes of the Lease or this resolution, and are in compliance with all applicable laws, including City's Charter; and, be it

FURTHER RESOLVED, That the City shall occupy the entire Premises for the full term of the lease unless funds for the Sheriff's Department rental payments are not appropriated in any subsequent fiscal year at which time City may terminate the lease with ninety (90) days advance written notice to Landlord. Said Lease shall be subject to certification as to funds by the Controller, pursuant to Section 3.105 of the Charter.
