

1 [Accept-Expend Grant – Public Defender]

3 **Resolution authorizing the Office of the Public Defender to accept and expend a grant**  
4 **in the amount of \$15,000 from the VanLobenSels/RembeRock Foundation for a social**  
5 **worker position dedicated to working with female juvenile offenders.**

7 WHEREAS, the Public Defender of the City and County of San Francisco provides  
8 legal representation to 30,000 people each year who are charged with misdemeanor and  
9 felony crimes in the City and County of San Francisco; and,

10 WHEREAS, included in its clients, are 1,400 juveniles, aged 10-16, who are arrested  
11 and booked at the Youth Guidance Center (YGC) in San Francisco; and,

12 WHEREAS, the majority of the juvenile clients represented by the Office of the Public  
13 Defender come from difficult family circumstances and live in dangerous and poverty stricken  
14 neighborhoods and are in need of social services; and,

15 WHEREAS, the juvenile justice system seeks to rehabilitate youthful offenders and  
16 avoid their return to the juvenile justice system in the future; and,

17 WHEREAS, a trend among the juvenile justice population is the increasing number of  
18 arrests for girls living in San Francisco and coming from our neighboring communities; and,

19 WHEREAS, a majority of these girls have been abused and have needs that are  
20 gender specific requiring much social work intervention and consistent monitoring of services;  
21 and,

22 WHEREAS, the Public Defender's Office has been selected to receive a grant in  
23 amount of \$15,000 from the VanLobenSels/RembeRock Foundation for a social worker  
24 position dedicated to working with female juvenile offenders; now, therefore, be it

25 **RESOLVED**, That it is the VanLobenSels/RembeRock Foundation's policy not to  
provide for indirect costs; and be it

3 City; and be it

4 FURTHER RESOLVED, That the Public Defender is authorized to accept and expend  
5 \$15,000 of the grant funds for a .50 FTE Social Worker position, classification 2910,  
6 dedicated to working with female juvenile offenders; and be it

7 FURTHER RESOLVED, That the Controller is directed to designate the position  
8 funded under this agreement as "G" or grant-funded positions which would terminate when  
9 the agreement expires.


