3 **Resolution authorizing the Department of Public Library to accept and expend a grant**  
4 **in the amount of \$153,000 from the Bill & Melinda Gates Foundation to provide**  
5 **sustainable public access computer hardware and software upgrades .**

7 WHEREAS, The primary mission of the San Francisco Public Library is to provide free  
8 and equal access to books and other knowledge resources to the community; and,

9 WHEREAS, Public access computer services to patrons provide access to information  
10 while in the library to a wealth of sources for research using the library's subscription  
11 databases, searching the library's catalog or searching the extended Web; and,

12 WHEREAS, Public access computer services help to bridge the Digital Divide by  
13 making services available to everyone; and,

14 WHEREAS, The Bill & Melinda Gates Foundation grant will provide funds which can  
15 be used to purchase additional public access computers or to replace or upgrade current  
16 public access computers; and,

17 WHEREAS, The grant terms prohibit including indirect costs in the grant budget, as all  
18 funds are to be used to purchase equipment, software, and support and installation services;  
19 now, therefore, be it

20 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
21 the grant budget; and be it

22 FURTHER RESOLVED, That the Public Library be authorized to accept and expend  
23 \$153,000 from the Bill & Melinda Gates Foundation to purchase public access computers,  
24 software, and support services for public access computers for the Main and Branch Libraries.




