9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes
11 the City Attorney to settle the action entitled John Pugh v. City and County of San Francisco,
12 et al., San Francisco Superior Court, Case No. CGC-22-603655 by the payment of \$60,000.
13 The lawsuit involves alleged personal injury from a vehicle collision.
