7 WHEREAS, the Crocker Amazon Playground, located near the corner of Geneva and
8 Moscow in San Francisco's District 11 was selected as the Neighborhood Parks Council's
9 Playground Campaign's pilot project and,

11 WHEREAS, neighbors, youth and community groups participated in a five month long
12 Community Design process to plan, develop and construct the largest children's playground in
13 a neighborhood park in the City of San Francisco; and,

15 WHEREAS, the Neighborhood Parks Council and a coalition of community
16 organizations, the Crocker Amazon Playground Committee raised \$250,000 to cover the
17 costs of the playground; and,

19 WHEREAS, Home Depot donated tools and provided numerous volunteers with
20 construction expertise; and,

22 WHEREAS, local business and individuals have made \$400,000 of in-kind donations in
23 the form of materials and labor; and,

25 WHEREAS, over 400 community members along with volunteers from Home Depot,
Neighborhood Parks Council, and KaBOOM came together on November 2nd, 2002 and
worked together to construct the new play space; and
