9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The San Francisco Administrative Code is hereby amended by amending Section
11 16.302, to read as follows:

12 **SEC. 16.302. PURPOSE.**

13 The purpose of this plan is to extend to employees of the City and County of San Francisco and
14 the Superior Court of California, County of San Francisco, certain benefits which ordinarily accrue
15 from participation in a Deferred Compensation Plan. The City and County of San Francisco does not
16 and cannot represent or guarantee that any particular federal or state income, payroll or other tax
17 consequence will occur by reason of an employee's participation in this plan. The participant should
18 consult with his or her own attorney or other representative regarding all taxes consequences of
19 participation of this plan. (Amended by Ord. 306-80, App. 6/27/80.)




