15 the following parties were named in the lawsuit: City and County of San Francisco, People of  
16 the State of California by and through Dennis J. Herrera, San Francisco City Attorney, as  
17 plaintiffs; Rehab Financial Corporation, Belinda Exon, Gayle Bloomingdale, and Barbara  
18 Wood, as defendants.
