8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter section 6.102(5), the Board of Supervisors hereby  
10 authorizes the City Attorney to settle the action entitled Lee Ann Crocker v. City and County of  
11 San Francisco, Does 1 to 10, San Francisco Superior Court, Case No. CGC-13-531600 by  
12 the payment of \$45,000.

13 Section 2. The above-named action was filed in San Francisco Superior Court on  
14 May 21, 2013, and the following parties were named in the lawsuit: Lee Ann Crocker,  
15 Plaintiff; City and County of San Francisco, Defendant.


