12 zoned; and, in conjunction with hotel permitted per Section 216(b)(I).

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions: now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 57  
18 Special On-Sale General liquor license to Michael J. Brewer for RC Social Club of San  
19 Francisco, Inc., located at 690 Market Street will serve the public convenience and  
20 necessity of the people of the City and County of San Francisco.

21 Conditions: (1) the premises shall not be open to the public but only  
22 operate as a private club serving members and guests. (2) The sale of alcoholic  
23 beverages for consumption off the premises is strictly prohibited and (3) No noise shall  
24 be audible beyond the control of the licensee.


