3 **Resolution enacting and rescinding parking regulations at various locations.**  
4

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
6 and the San Francisco Traffic Code, the following regulations governing the parking of  
7 vehicles are hereby enacted or rescinded as designated below:

8 **RESIDENTIAL PERMIT PARKING AREA "D" - ESTABLISH**

9 Baden Street, west side, between Mangels to the northern terminus (400 block)  
10 (includes addresses, but no signs will be posted).

11 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

12 8th Street, east side, from 52 feet to 78 feet south of Heron Street (26 foot zone,  
13 accommodating 6 unmetered motorcycle spaces); and,

14 15th Street, north side, from Market Street to 20.5 feet easterly (18-foot space,  
15 accommodating 5 unmetered motorcycle spaces).

16 **TOW-AWAY, NO PARKING ANYTIME - ESTABLISH**

17 Carolina Street south side, between Wisconsin Street and Caire Terrace (65-foot  
18 zone).

19 **RESIDENTIAL PERMIT AREA "R" (2-HOUR TIME LIMIT, 9 AM TO 6 PM, MONDAY  
THROUGH SATURDAY) - ESTABLISH**

20 Gough Street, west side, between Fulton and Grove Street (replaces 1-Hour signed  
21 time limit).

22 **RESIDENTIAL PERMIT PARKING AREA "F," 9 AM TO 4 PM, MONDAY THROUGH  
23 FRIDAY - ESTABLISH**

24 Spruce Street, east side, from California Street to 140 feet northerly; and,

25 California Street, south side, from Parker Avenue to 110 feet easterly.

1 **NO PARKING, 7 AM TO 8 AM, MONDAY THROUGH FRIDAY - RESCIND**

2 Maple Street, both sides, between California and Sacramento Streets.

3 **PARKING METER AREA 3 (2 HOUR TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH**  
4 **SATURDAY) - ESTABLISH**

5 California Street, north side, between Spruce and Cherry Streets;

6 California Street, south side, between Spruce Street and 110 feet east of Parker  
7 Avenue;

8 Gough Street, east side, between Grove and Fulton Streets;

9 Presidio Avenue, west side, from California Street to Pine Street;

10 Stanyan Street, east side, from Haight Street to 90 feet southerly; and,

11 19th Street, north side, from 80 feet to 110 feet west of Castro (to accommodate  
12 installing three motorcycle parking meters).

13 **NO PARKING, MIDNIGHT TO 6:00 A.M., EVERYDAY - ESTABLISH**

14 Alice B. Toklas Place, south side, from 24 feet east of Van Ness Avenue to 130 feet  
15 easterly (100 block).

16 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

17 Stevenson Street, south side, from 5th Street to 100 feet westerly; and,

18 Marin Street, north side, from Kansas Street to 50 feet westerly.

19 **TOUR BUS PARKING - RESCIND**

20 Mint Street, east side, between Mission and Jessie Streets.

21  
22 Categorically exempt from Environmental Review  
23 Class 1(c)(9) changes in the traffic and parking  
24 regulations where such changes do not establish a  
25 higher speed limit or result in more than a negligible

**RESIDENTIAL PERMIT PARKING AREA "D" - ESTABLISH**

Baden Street, west side, between Mangels to the northern terminus (400 block) (includes addresses, but no signs will be posted).

**UNMETERED MOTORCYCLE PARKING - ESTABLISH**

8th Street, east side, from 52 feet to 78 feet south of Heron Street (26 foot zone, accommodating 6 unmetered motorcycle spaces); and,  
15th Street, north side, from Market Street to 20.5 feet easterly (18-foot space, accommodating 5 unmetered motorcycle spaces).

**TOW-AWAY, NO PARKING ANYTIME – ESTABLISH**

Carolina Street south side, between Wisconsin Street and Caire Terrace (65-foot zone).

**RESIDENTIAL PERMIT AREA "R" (2-HOUR TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY) - ESTABLISH**

Gough Street, west side, between Fulton and Grove Street (replaces 1-Hour signed time limit).

**NO PARKING, 7 AM TO 8 AM, MONDAY THROUGH FRIDAY - RESCIND**

Maple Street, both sides, between California and Sacramento Streets.

**PARKING METER AREA 3 (2 HOUR TIME LIMIT, 9 AM TO 6 PM, MONDAY THROUGH SATURDAY) - ESTABLISH**

California Street, north side, between Spruce and Cherry Streets;  
California Street, south side, between Spruce Street and 110 feet east of Parker Avenue;  
Gough Street, east side, between Grove and Fulton Streets;  
Presidio Avenue, west side, from California Street to Pine Street;  
Stanyan Street, east side, from Haight Street to 90 feet southerly; and,  
19th Street, north side, from 80 feet to 110 feet west of Castro (to accommodate installing three motorcycle parking meters).

**NO PARKING, MIDNIGHT TO 6:00 A.M., EVERYDAY - ESTABLISH**

Alice B. Tokias Place, south side, from 24 feet east of Van Ness Avenue to 130 feet easterly (100 block).

**TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

Stevenson Street, south side, from 5th Street to 100 feet westerly; and,  
Marin Street, north side, from Kansas Street to 50 feet westerly.

**TOUR BUS PARKING – RESCIND**

Mint Street, east side, between Mission and Jessie Streets.


