2 DETERMINING THAT THE TRANSFER OF A TYPE 21 OFF-SALE GENERAL ALCOHOLIC BEVERAGE  
3 CONTROL LICENSE TO KARINA NELSON VANCAMP FOR RUSSELL'S CONVENIENCE STORE  
4 LOCATED AT 390 SUTTER STREET, WILL SERVE THE CONVENIENCE OF THE PEOPLE OF THE CITY  
5 AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION 23958.4 OF THE CALIFORNIA  
6 BUSINESS AND PROFESSIONS CODE WITH CONDITIONS.

8 WHEREAS, Karina Nelson VanCamp is seeking transfer of a Type 21 off-sale general alcoholic beverage  
9 control license for Russell's Convenience Store located at 390 Sutter Street; and,

10 WHEREAS, The City Planning Department has verified that the area is properly zoned; and,

11 WHEREAS, The Police Department recommends that the liquor license application be approved with  
12 conditions; now, therefore, be it

13 RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code,  
14 the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that  
15 the transfer of a Type 21 off-sale general alcoholic beverage control license to Karina Nelson VanCamp for  
16 Russell's Convenience Store, located at 390 Sutter Street, will serve the convenience of the people of the City and  
17 County of San Francisco.

19 Conditions: (1) No signs, displays, or any other material advertising or indicating that alcoholic beverages  
20 are for sale at the premises shall be displayed so that such material is visible from the exterior of the premises. (2)  
21 Wine shall not be sold in bottles or containers smaller than 750 ml, wine coolers shall not be sold in units of less  
22 than a four-pack, and beer and malt beverages shall not be sold in containers greater than 16 ounces or in units less  
23 than a six-pack. (3) No wine shall be sold with an alcoholic content greater than 15% by volume. (4) Sales of  
24 alcoholic beverages shall not be permitted after the hours of 10:00 p.m. each day of the week.


