(2) Wine shall not be sold in bottles or containers smaller than 750 ml, wine coolers shall not be sold in units of less than a four-pack, and beer and malt beverages shall not be sold in containers greater than 16 ounces or in units less than a six-pack. (3) No wine shall be sold with an alcoholic content greater than 15% by volume. (4) Sales of alcoholic beverages shall not be permitted after the hours of 10:00 p.m. each day of the week.
