Resolution urging Representatives Nancy Pelosi and Tom Lantos to add their names to the list of Representatives sponsoring HR 4232, the End the War in Iraq Act of 2005, introduced by Representative Jim McGovern; and urging Senators Diane Feinstein and Barbara Boxer to file legislation to the same effect in the Senate.

WHEREAS, Sixty-three percent of San Francisco's voters have already called on the Federal government to "bring the troops safely home now;" when they passed Proposition N in November of 2004; now, therefore, be it

RESOLVED, That the Board of Supervisors urge Representatives Nancy Pelosi and Tom Lantos to add their names to the list of Representatives sponsoring HR 4232, the End the War in Iraq Act of 2005, introduced by Representative Jim McGovern; and urge Senators Diane Feinstein and Barbara Boxer to file such legislation in the Senate to prohibit the use of funds to deploy United States Armed Forces to Iraq, with the exception of a) providing for the safe and orderly withdrawal of the Armed Forces from Iraq; or b) ensuring the security of Iraq and the transition to democratic rule by carrying out consultations with the Government of Iraq, other foreign governments, the North Atlantic Treaty Organization (NATO), the United Nations, and other international organizations; or c) providing financial assistance or equipment to Iraqi security forces and international forces in Iraq; with the further proviso that this shall not restrict the use of funds to carry out social and economic reconstruction activities in Iraq; and, be it

FURTHER RESOLVED, That the Board of Supervisors direct the clerk of the board to send a copy of this resolution to Representatives Nancy Pelosi and Tom Lantos and Senators Diane Feinstein and Barbara Boxer.
