1	[Settlement of Unlitigated Claim - The Nederlander Company LLC, dba Broadway San Francisco, LLC - \$55,000]

3	Ordinance authorizing settlement of the claim filed by The Nederlander Company LLC,	
4	dba Broadway San Francisco, LLC, against the City and County of San Francisco, et	
5	al., and any lawsuit that arises from the claim, for \$55,000; the claim was filed on
