3 **Ordinance authorizing settlement of the lawsuit filed by Noel Clay against the City and**
4 **County of San Francisco for \$70,750; the lawsuit was filed on January 16, 2019, in San**
5 **Francisco Superior Court, Case No. CGC-19-572858; entitled Noel Clay v. City and**
6 **County of San Francisco, Etelvina Blanco; the lawsuit involves an alleged injury when**
7 **plaintiff’s vehicle collided with a Department of Public Works vehicle.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Noel Clay v. City and County of San
12 Francisco, Etelvina Blanco, San Francisco Superior Court, Case No. CGC-19-572858 by the
13 payment of \$70,750. The lawsuit involves an alleged injury when plaintiff’s vehicle collided
14 with a Department of Public Works vehicle.

15 Section 2. The above-named action was filed in San Francisco Superior Court on
16 January 16, 2019, and the following parties were named in the lawsuit: Plaintiff: Noel Clay,
17 and Defendants: City and County of San Francisco, Etelvina Blanco.
