Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

The Planning Department has determined that the actions contemplated in this Ordinance are in compliance with the California Environmental Quality Act (California Public Resources Code sections 21000 et seq.).

Section 2. The San Francisco Park Code is hereby amended, <u>subject to the review</u> and approval of the Recreation and Park Commission, by adding Section 12.44, to read as follows:

SEC. 12.44. RECREATION PROGRAM FEES.

(a) The following hourly fees will be charged for recreation programs.
