

LEGISLATIVE DIGEST

[Waiver of temporary street space occupancy fee on May 15, 2010 for Small Business Week Sidewalk Sale.]

Ordinance waiving the fee in Public Works Code Section 724.1(b) for temporary street space occupancy in certain sections of the City on Saturday, May 15, 2010 as part of Small Business Week.

Existing Law

Currently, Public Works Code Section 724.1 subsection (b) requires a fee for a temporary street occupancy permit.

Amendments to Current Law

This legislation shall waive the permit fee for Saturday, May 15, 2010, between 7 am and 9 pm within certain designated streets within San Francisco.

Amendments in Budget and Finance Subcommittee

This amendment extends the street location from Irving Street between Sixth Avenue and Tenth Avenue to Nineteenth Avenue. In addition, this amendment corrects errors in street locations.

Background / Overview

The U.S. celebrates the contribution of small business to America's economy each year with National Small Business Week. The Small Business Commission is a co-sponsor with the San Francisco District Office of the U.S. Small Business Administration, San Francisco Chamber of Commerce, Council of District Merchants, and fiscal sponsor Wells Fargo Bank, along with eight other sponsoring organizations to host San Francisco's sixth annual Small Business Week.

Small Business Week in San Francisco is May 15 through 21, 2010. It is a week of activities beginning with the City-wide Shop the Neighborhood on May 15 in 20 merchant corridors throughout the City. This is the fourth year the Small Business Commission in coordination with Department of Public Works is requesting the approval from the Board of Supervisors in waiving the fee in Public Works Code Section 724.1(b) for temporary street space occupancy. These sidewalk sales are meant to promote the commercial corridors, draw people to the neighborhoods and provide a much needed economic boost in this current economy. The Small Business Week sidewalk sales is a Small Business Commission initiated event. The Small Business Commission is not requesting a waiver of fees that City would otherwise take in, therefore this legislation is a matter of formality.

History of Fee Waiver Participation

2005 fees were waived.

6 permits issued, 12 block face. 12 block faces at \$52.95 + \$1.02 surcharge per permit = \$641.52

2006 fees were not waived.

1 permit issued for 1 block face. 1 block face at \$53.46 + \$1.02 surcharge per permit = \$54.40
