9 WHEREAS, Upon the completion of a request for proposals process, the Airport  
10 Commission awarded International Terminal Food and Beverage Concession Lease No.  
11 16-0024 to the highest-ranking responsive and responsible proposer, SSP America, Inc.,  
12 by Airport Commission Resolution No. 16-0024 adopted January 19, 2016; and

13 WHEREAS, International Terminal Food and Beverage Concession Lease No. 16-0024  
14 has a term of seven years with three options to extend of one year each for a pre-security  
15 concession, and an initial Minimum Annual Guarantee of \$196,000; now, therefore, be it

16 RESOLVED, That this Board of Supervisors hereby approves International Terminal  
17 Food and Beverage Concession Lease No. 16-0024, a copy of which is on file with the Clerk  
18 of the Board of Supervisors in File No. 160457; and, be it

19 FURTHER RESOLVED, That within thirty days of the lease being fully executed by all  
20 parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
21 inclusion into the official file.


