Ordinance authorizing settlement of the lawsuit filed by Luis Angel Garcia Valencia against the City and County of San Francisco for \$41,000; the lawsuit was filed on November 30, 2018, in San Francisco Superior Court, Case No. CGC-18-571714; entitled Luis Angel Garcia Valencia v. City and County of San Francisco, et. al; the lawsuit involves alleged personal injury from a vehicle collision.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby authorizes the City Attorney to settle the action entitled Luis Angel Garcia Valencia v. City and County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-18-571714 by the payment of \$41,000. The lawsuit involves alleged personal injury from a vehicle collision.

Section 2. The above-named action was filed in San Francisco Superior Court on November 30, 2018, and the following parties were named in the lawsuit: plaintiff: Luis Angel Garcia Valencia; defendants: City and County of San Francisco, Michael Joseph Callahan.
