3 **Ordinance authorizing settlement of the lawsuit filed by Taryn Saldivar against the City**
4 **and County of San Francisco for \$190,000; the lawsuit was filed on August 6, 2020, in**
5 **United States District Court - Northern District of California, Case No. 20-cv-05474;**
6 **entitled Taryn Saldivar v. City and County of San Francisco, et al.; the lawsuit involves**
7 **unlawful detention and arrest.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Taryn Saldivar v. City and County of
12 San Francisco, et al., United States District Court – Northern District of California, Case No.
13 20-cv-05474 by the payment of \$190,000. The lawsuit involves unlawful detention and arrest.

14 Section 2. The above-named action was filed in United States District Court – Northern
15 District of California on August 6, 2020, and the following parties were named in the lawsuit:
