
2 APPROVING FINAL MAP OF ST. FRANCIS BAY CONDOMINIUMS, A 17-LOT SUBDIVISION

11 Francis Bay Condominiums", A 17-Lot Subdivision Project.


12 FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own and
