3 **Resolution authorizing the Department of Public Health to accept and expend**  
4 **retroactively a state grant in the amount of \$41,892 from the California Family Health**  
5 **Council to participate in a program entitled “Infertility Prevention Project Training**  
6 **Program” for the period of January 1, 2012, through December 31, 2012.**

8 WHEREAS, California Family Health Council has agreed to fund Department of Public  
9 Health (DPH) in the amount of \$41,892 for the period of January 1, 2012 through December  
10 31, 2012; and,

11 WHEREAS, The full project period of the grant starts on January 1, 2012 and ends on  
12 December 31, 2013, with year three subject to availability of funds and satisfactory progress  
13 of the project; and,

14 WHEREAS, As a condition of receiving the grant funds, California Family Health  
15 Council requires the City to enter into an agreement (the “Agreement”), a copy of which is on  
16 file with the Clerk of the Board of Supervisors in File No. 120203; which is hereby declared to  
17 be a part of this resolution as if set forth fully herein; and,

18 WHEREAS, The purpose of this project will fund a Nurse Practitioner to perform clinical  
19 services and trainings in support of the CDC Infertility Prevention Project; and,

20 WHEREAS, An ASO amendment is not required as the grant partially supports one  
21 existing position, one Nurse Practitioner (Job Class #2328) at .20 FTE, for the period of  
22 January 1, 2012, through December 31, 2012; and,


23 WHEREAS, The budget includes a provision for indirect costs in the amount of \$419;  
24 and,

1 RESOLVED, That DPH is hereby authorized to accept and expend a grant retroactively  
2 in the amount of \$41,892 from the California Family Health Council; and, be it


3 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and


