17 achieving a quorum, the Board of Supervisors now wishes to follow the tradition established
18 by many other sitting legislative bodies in the United States and provide for a scheduled
19 recess period, and selects the period from August 24 through September 12, 1999 for this
20 recess; now, therefore, be it




