11	San Francisco International Airport on May 13, 2019, pursuant to Airline Operating and Space
12	Permit No. 4696; and
13	WHEREAS, The City and County of San Francisco, acting by and through its Airport
14	Commission ("City"), has entered into a 2011 Lease and Use Agreement ("2011 Lease") with
15	57 other airlines, effective July 1, 2011 for a term of ten years, to provide for the continuation
16	of flight operations and terminal rental by such airlines at the Airport; and
17	WHEREAS, EI Al desires to become a signatory to the 2011 Lease, which grants it the
18	right to conduct flight operations with the City under the same terms and conditions as other
19	signatory airlines, except that the term will be approximately two years to commence on the
20	first day of the month following full approval by the City; and
21	WHEREAS, El Al rents approximately 2,806 square feet of Exclusive Use Space and
22	uses the International Terminal Joint Use Spaces and support facilities, as summarized on
23	Attachment A; and
24	WHEREAS, On May 21, 2019, the Airport Commission adopted Resolution No. 19-
25	0126 approving a 2011 Lease with El Al; and

1	WHEREAS, A copy of the 2011 Lease is on file with the Clerk of the Board of
2	Supervisors in File No, which is hereby declared to be a part of this
3	resolution as if set forth fully herein; now, therefore, be it
4	RESOLVED, That this Board of Supervisors hereby approves 2011 Lease No. 19-0126
5	with El Al; and, be it
6	FURTHER RESOLVED, That within 30 days of the contract being fully executed by all
7	parties, the Airport Commission shall provide a copy of the final contract to the Clerk of the
8	Board for inclusion into the official file.
