WHEREAS, San Francisco-Marin Food Bank submitted a proposal, and was awarded the grant for the total amount of \$6,297,500 for the period of July 1, 2022, through January 31, 2023; and

WHEREAS, On July 28, 2022, the Human Services Commission approved the Citywide Grocery Access grant with San Francisco-Marin Food Bank in the amount of \$6,297,500 for the period of July 1, 2022, through January 31, 2023; and

WHEREAS, The Human Services Agency entered into a grant agreement with San Francisco-Marin Food Bank for the period from July 1, 2022, to January 31, 2023, for a total not to exceed amount of \$6,297,500; and

WHEREAS, Charter, Section 9.118(b), provides that agreements entered into by a department requiring expenditures exceeding ten million dollars shall be subject to approval by the Board of Supervisors; and

WHEREAS, On December 15, 2022, the Human Services Commission approved the first amendment to the Citywide Grocery Access grant with San Francisco-Marin Food Bank in the amount of \$11,228,328 for the period of July 1, 2022, through June 30, 2023; and

WHEREAS, The City and County of San Francisco, wishes to amend the grant agreement with San Francisco-Marin Food Bank to increase the grant amount by \$4,930,828 for a revised not to exceed amount of \$11,228,328 and to extend the grant period from February 1, 2023, for a total period of July 1, 2022, through June 30, 2023; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby authorizes the amendment to the grant agreement between the City and County of San Francisco and San Francisco-Marin Food Bank to provide the Citywide Grocery Access program increasing the grant amount by \$4,930,828 for a revised not to exceed amount of \$11,228,328 and extending the grant period from February 1, 2023, for a total period of July 1, 2022, through June 30, 2023; and, be it

FURTHER RESOLVED, That within thirty (30) days of the amendment being fully executed by all parties, the Human Services Agency shall provide the final grant agreement to the Clerk of the Board for inclusion into the official file.
