Resolution determining that the transfer of a Type 48 on-sale general public liquor license from 2237 Mason Street to 222 Powell Street (District 3), to Mark E. Rennie for Sirhed Enterprises, LLC, dba Sam's Cable Car Lounge, will serve the public convenience or necessity of the people of the City and County of San Francisco, in accordance with Section 23958.4 of the California Business and Professions Code, and recommending that the California Department of Alcoholic Beverage Control impose conditions on the issuance of the license.

WHEREAS, Mark E. Rennie is seeking the transfer of a Type 48 on-sale general public liquor license from 2237 Mason Street to 222 Powell Street for Sirhed Enterprises, LLC, dba Sam's Cable Car Lounge; and,

WHEREAS, The Planning Department has verified that the area is properly zoned and recommends approval; and,

WHEREAS, The Police Department has filed a protest with the Department of Alcoholic Beverage Control under Section 24013 of the California Business and Professions Code, recommending that the Department of Alcoholic Beverage Control issue the liquor license with conditions; and

WHEREAS, The conditions recommended by the Police Department are: 1) Sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 9:00 a.m. and 2:00 a.m. each day of the week; 2) The sale of beer for consumption off the premises is strictly prohibited; 3) Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is strictly prohibited on any

sidewalks or property adjacent to the licensed premises under the control of the licensee as depicted on the ABC-257; 4) No noise shall be audible beyond the area under the control of the licensee(s) as defined by the ABC-257 dated 6/5/12; and 5) The petitioner shall utilize electronic surveillance and recording equipment that is able to view all exits and entrance points of the exterior of the premises. The electronic surveillance/recording shall be operational at all times that the premises open to the public. Said electronic recording shall be maintained and kept for a minimum of seven (7) days, and shall be made available to Law Enforcement on demand; now, therefore, be it

RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code, the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that the issuance of a Type 48 on-sale general public liquor license from 2237 Mason Street to 222 Powell Street, to Mark E. Rennie for Sirhed Enterprises, LLC, dba Sam's Cable Car Lounge, will serve the public convenience or necessity of the people of the City and County of San Francisco; and

FURTHER RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby endorses and adopts the recommendations of the Police Department listed above, and recommends that the Department of Alcoholic Beverage Control issue the license with those conditions.
