

1 [Contract Amendment - Cornerstone Technology Partners, JV - \$22,820,000]

3 **Resolution authorizing the Office of Contract Administration to enter into the**
4 **Fourth Amendment between the City and Cornerstone Technology Partners, JV**
5 **(part of the Technology Store procurement vehicle), in which the amendment**
6 **shall increase the contract limit from \$12,490,000 to \$22,820,000 for the term**
7 **ending December 31, 2013.**

9 WHEREAS, The Office of Contract Administration, by competitive bidding,
10 developed the Technology Store procurement method for the purchase of products and
11 services related to Information Technology; and

12 WHEREAS, Cornerstone Technology Partners, JV is one of the three products
13 vendors who are part of the Technology Store; and

14 WHEREAS, The original contract with Cornerstone Technology Partners, JV
15 dated January 1, 2009 has a term of three years through December 31, 2011 with
16 options to extend the term through December 31, 2013, and has an original contract
17 limit of \$12,000,000; and

18 WHEREAS, The Board of Supervisors approved the original contract on
19 December 9, 2008 by Resolution #508-08; and

20 WHEREAS, The Director of the Office of Contract Administration and the
21 Purchaser approved the First Amendment to the contract on December 13, 2011 to
22 exercise the first of two options to extend the contract by one year through December
23 31, 2012, and to update standard contractual clauses; and

24 WHEREAS, The Director of the Office of Contract Administration and the
25 Purchaser approved the Second Amendment to the contract on December 19, 2012 to

1 exercise the second of two options to extend the contract by one year through
2 December 31, 2013; and

3 WHEREAS, The Director of the Office of Contract Administration and the
4 Purchaser approved the Third Amendment to the contract on July 02, 2013 to increase
5 the contract limit from \$12,000,000 to \$12,490,000; and

6 WHEREAS, The Office of Contract Administration estimates that the money
7 projected to be spent with Cornerstone Technology Partners could reach the contract's
8 limit in the reasonably near future; and

9 WHEREAS, Charter Section 9.118(b) "Contract and Lease Limitations," requires
10 the Board of Supervisors to approve any contract estimated to exceed \$10 million in
11 expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be
12 it

13 RESOLVED, That the Board of Supervisors authorizes the Director of the Office
14 of Contract Administration and the Purchaser to enter into the Fourth Amendment to
15 the contract with Cornerstone Technology Partners, JV to increase the contract limit
16 from \$12,490,000 to \$22,820,000 in substantially the form on file with the Clerk of the
17 Board in such final form as approved by the Purchaser and Director of the Office of
18 Contract Administration and the City Attorney; and, be it

19 FURTHER RESOLVED, That within thirty (30) days of the contract being fully
20 executed by all parties, the Purchaser and Director of the Office of Contract
21 Administration shall provide the final contract to the Clerk of the Board for inclusion into
22 the official file.




