

1 [Proposition J Contract – Security Guard Services: 1380 Howard Street]

3 **Resolution concurring with Controller's certification that security guard services at the**  
4 **Department of Parking and Traffic Citation and Hearing Offices located at 1380 Howard**  
5 **Street can be practically performed by a private contractor at a lower cost than by City**  
6 **and County employees.**

8 WHEREAS, Section 10.104.15 of the San Francisco Charter allows City Departments  
9 to contract for services performed by employees subject to civil service examination when it  
10 has been determined by the Office of the Controller that can be practically performed under  
11 private contract at a lower cost to the City than similar work performed by City and County  
12 employees; and

13 WHEREAS, In 2003 the Office of Contract Administration, Purchasing Division  
14 awarded a four-year contract for security guard services at the Department of Parking and  
15 Traffic Citation and Hearing Offices at 1380 Howard Street to Zonux Security Solutions; and

16 WHEREAS, The Office of the Controller has certified that the requirements of Charter  
17 section 10.104.15 have been satisfied for Fiscal Year 2004-2005 and has determined that  
18 contracting for the services provided for under this contract is more economical than providing  
19 the same services with City and County employees; and

20 WHEREAS, The Controller's certification is on file with the Clerk of the Board of  
21 Supervisors in File No. 041082, which is hereby declared to be a part of this  
22 resolution as if set forth fully herein; and,

23 WHEREAS, On July 20, 2004 the Board of Directors of the Municipal Transportation  
24 Agency adopted Resolution 04-107; a copy of which is on file with the Clerk of the Board of  
25 Supervisors in File No. 041082, which is hereby declared to be a part of this

1 resolution as if set forth fully herein, recommending that the Board of Supervisors concur with  
2 Controller's determination; now, therefore, be it

3 RESOLVED, That the Board of Supervisors concurs with the Controller's certification  
4 that security guard services at the Department of Parking and Traffic Citation and Hearing  
5 Offices at 1380 Howard Street can be practically performed by a private contractor at a lower  
6 cost than by City and County employees for fiscal year 2004-2005.


