[Affirming the Approval of a Final Mitigated Negative Declaration - 480 Potrero Avenue]

Motion affirming the approval of a Final Mitigated Negative Declaration under the California Environmental Quality Act by the Planning Commission for a project located at 480 Potrero Avenue.

WHEREAS, The Planning Commission has approved a Final Mitigated Negative Declaration (FMND) for a project located at 480 Potrero Avenue under the California Environmental Quality Act ("CEQA"), the CEQA Guidelines, and San Francisco Administrative Code Chapter 31. The proposed project involves construction of a six-story, 58-foot-tall mixed-use building, which would include residential, ground-floor retail, and parking uses ("proposed project"). By letters to the Clerk of the Board received on August 28, 2013, Jean Bogiages and Juan M. Jayo, on behalf of the Mariposa Utah Neighborhood Association ("MUNA"), and Mica I. Ringel (Appellants), appealed the Planning Commission's approval of the FMND. Appellants provided a copy of Planning Commission Motion No. 18944, dated August 8, 2013, upholding the Preliminary Mitigated Negative Declaration on appeal to that body. At the same August 8, 2013 hearing, the Planning Commission approved a Large Project Authorization under Planning Code Section 329 for the proposed project; and

FURTHER MOVED, That after carefully considering the appeal of the FMND, including the written information submitted to the Board of Supervisors and the public testimony presented to the Board of Supervisors at the hearing on the FMND, this Board concludes that the project qualifies for a FMND and that no fair argument supported by substantial evidence in the record has been presented that the project as proposed would result in any significant impact on the environment.
