

1 [Contract Amendment - Regents of the University of California, Division of Substance
2 Abuse and Addiction Medicine - Behavioral Health Services - Not to Exceed \$14,737,704]

3 **Resolution approving Amendment No. 1 to the agreement between the Regents of the**
4 **University of California at San Francisco, Division of Substance Abuse Medicine, and**
5 **the Department of Public Health for behavioral health narcotic addiction treatment**
6 **services, to increase the agreement amount by \$5,129,609 for an amount not to exceed**
7 **\$14,737,704; and to extend the term by one year, from July 1, 2020, for a total**
8 **agreement term of July 1, 2018, through June 30, 2021.**

10 WHEREAS, The Department of Public Health’s (DPH’s) Behavioral Health Services
11 (BHS) conducted a Request For Proposals in September 2016 and selected Regents of the
12 University of California at San Francisco, Division of Substance Abuse Medicine (UCSF
13 DSAAM) to provide narcotic addiction treatment services, subsequently making a contract
14 with UCSF for the period of July 1, 2018, through June 30, 2020, and a total contract amount
15 not to exceed \$9,608,095; and

16 WHEREAS, As a result of the pending FYs 2020-2021 and 2021-2022 projected
17 Citywide budget deficits and the delayed approval of the City’s annual budget due to the
18 impact of COVID-19, DPH is proposing a one-year extension of this contract to ensure
19 sufficient ongoing funding to continue these critical services through the completion of budget
20 deliberations; and

21 WHEREAS, Under this agreement, UCSF provides narcotic treatment to low or no-
22 income patients with opioid use disorders who may also have mental health issues or life-
23 threatening medical problems, be experiencing homelessness, or have other significant
24 barriers to receiving proper care at several sites throughout the City; these services are
25 provided through the following programs including the (a) Opiate Treatment Outpatient

1 Program (OTOP) at Zuckerberg San Francisco Hospital (ZSFG), and the OTOP van in the
2 Bayview neighborhood, (b) the Office-Based Buprenorphine Induction Clinic (OBBIC), (c) the
3 Office-Based Opiate Treatment (OBOT) programs at the Tom Waddell, Potrero Hill, and
4 Positive Health Program primary care clinics, and (d) through services provided by the ZSFG
5 and BHS pharmacies, as well as OTOP Ancillary services; now, therefore, be it

6 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public
7 Health and the Director of the Office of Contract Administration/Purchaser, on behalf of the
8 City and County of San Francisco, to execute Amendment No. 1 to the agreement with the
9 Regents of the University of California at San Francisco, Division of Substance Abuse
10 Medicine for behavioral health narcotic addiction treatment services, to increase the
11 agreement amount by \$5,129,609 for an amount not to exceed \$14,737,704; and to extend
12 the term by one year, from July 1, 2020, for a total agreement term of July 1, 2018, through
13 June 30, 2021; and, be it

14 FURTHER RESOLVED, That the Board of Supervisors authorizes the
15 Department of Public Health to enter into any amendments or modifications to the
16 contract, prior to its final execution by all parties, that the Department determines, in
17 consultation with the City Attorney, are in the best interest of the City, do not otherwise
18 materially increase the obligations or liabilities of the City, are necessary or advisable to
19 effectuate the purposes of the contract, and are in compliance with all applicable laws;
20 and, be it

21 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed
22 by all parties, the Director of Health and/or the Director of the Office of Contract
23 Administration/Purchaser shall provide the final contracts to the Clerk of the Board for
24 inclusion into the official File No. _____.
