3 **Motion to suspend Board of Supervisors Rules of Order, Rule 2.28.1, pursuant to Rule**  
4 **4.37, to permit the introduction of a proposed Charter amendment to amend Appendix**  
5 **A8.506-2 relating to retirement benefits for miscellaneous safety employees.**

7 WHEREAS, Board of Supervisors Rules of Order Rule 2.28.1 provides that a proposed  
8 Charter amendment shall be introduced by a Supervisor at a regular Board meeting held not  
9 less than 169 days prior to the election at which it is to be acted upon by the electors; and,

10 WHEREAS, The last regular Board meeting held 169 days prior to the November 5,  
11 2002 election was on Tuesday, May 20, 2002; and,

12 WHEREAS, A proposed Charter amendment amending Appendix A8.506-2 relating to  
13 retirement benefits for miscellaneous safety employees is in the public interest and should be  
14 submitted to the voters for the November 5, 2002 ballot; and,

15 WHEREAS, The proposed Charter amendment is on file with the Clerk of the Board of  
16 Supervisors in File No. 020899, which is hereby declared to be a part of this motion as if set  
17 forth fully herein; and,

18 WHEREAS, This proposed Charter amendment will be introduced at the next regularly  
19 scheduled Board meeting held on Monday, May 28, 2002, but within the 169 days prior to the  
20 November 5, 2002 election; now, therefore, be it

21 MOVED, That, pursuant to Rule 4.37, Rule 2.28.1 is suspended for the purpose of  
22 permitting introduction of the proposed Charter amendment to amend Appendix A8.506-2  
23 relating to retirement benefits for miscellaneous safety employees; and, be it

24 FURTHER MOVED, That the Clerk of the Board shall refer the proposed Charter  
25 amendment to the appropriate Board committee for public hearing.
