13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. San Francisco Small Business Week is May 15–20, 2017. To promote
15 Small Business Week and permit sidewalk sales of merchandise, Public Works Code Section
16 724.1(b), setting a fee for temporary street space occupancy, is hereby waived for Saturday,
17 May 20, 2017, between the hours of 7 a.m. and 9 p.m., for the following areas:



10 Section 2. All other provisions of Public Works Code Sections 724 et seq. shall remain
11 in full effect.

13 Section 3. Effective Date; Retroactivity.

14 (a) This ordinance shall become effective 30 days after enactment. Enactment occurs
15 when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or does not
16 sign the ordinance within ten days of receiving it, or the Board of Supervisors overrides the
17 Mayor's veto of the ordinance.

18 (b) This ordinance shall be retroactive to May 20, 2017.

REVISED LEGISLATIVE DIGEST

(Substituted, 6/27/2017)

[Public Works Code - Waiver of Temporary Street Space Occupancy Fee for Small Business Week Sidewalk Sales]

Ordinance retroactively waiving the fee required by Public Works Code, Section 724.1(b), for temporary street space occupancy permits on certain City streets on Saturday, May 20, 2017, as part of Small Business Week sidewalk sales.

Existing Law

Section 724.1(b) of the Public Works Code requires that a fee of \$57.62 per day be charged “[f]or temporary street space occupancy for any purpose other than a building construction operation.”

Amendments to Current Law

This ordinance would temporarily waive the fee required by section 724.1(b) of the Public Works Code, in certain parts of the City, in observance of Small Business Week. The fee would be waived between 7 a.m. and 9 p.m. on Saturday, May 20, 2017. The ordinance is retroactive to May 20, 2017.
