11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Jada Navaeh Williams v. City and  
13 County of San Francisco, et al., San Francisco Superior Court, Case No. CGC-24-614172 by  
14 the payment of \$80,000. The lawsuit involves an alleged personal injury from a vehicle  
15 collision involving officers from the San Francisco Police Department.

16 Section 2. The above-named action was filed in San Francisco Superior Court on April  
17 24, 2024, and the following parties were named in the lawsuit: Plaintiff Jada Navaeh Williams;
