WHEREAS, The risk of suicide among GLBT individuals is two to three times higher than the average risk; and

WHEREAS, SAMHSA, an agency within the Department of Health and Human Services that is funding the conference recently instructed the contractor running the program to omit the words "gay," "lesbian," "bisexual" and transgender" from the title of the talk and to use instead the term "sexual orientation"; and

WHEREAS, This action on the part of our federal government further marginalizes this at-risk population, and dilutes the LGBT community's efforts to prevent suicide; now, therefore, be it

RESOLVED, That the San Francisco Board of Supervisors strongly believes in the need for culturally sensitive services, particularly for populations with acute need of suicide prevention; and, be it

FURTHER RESOLVED, That the San Francisco Board of Supervisors repudiates the actions of the Department of Health and Human Services and requests that all future DHHS-funded conferences recognize and respect the dignity of the LGBT community.
