Resolution approving the award of Municipal Railway Contract No. CS-132, Quality Assurance and Construction Management Services for Phase I of the Third St. Light Rail Transit Project, to Sverdrup Civil Inc. for an amount not to exceed \$16,000,000 and for a term not to exceed five years; placing \$12,381,055 on reserve.

WHEREAS, On June 20, 2000, the Municipal Transportation Agency (MTA) Board of Directors adopted Resolution No. 00-070, which authorized the Director of Transportation to advertise a Request for Proposals (RFP), select the most qualified proposer, and negotiate a contract with that proposer to procure quality assurance and construction management services at a cost not to exceed \$16,000,000, and for a term not to exceed five years; and,

WHEREAS, The Municipal Transportation Agency issued an RFP on August 21, 2000 and received seven proposals in response to the RFP on September 29, 2000; and,

WHEREAS, On July 3, 2001, pursuant to Resolution No. 01-080, the MTA Board of Directors approved the award of Contract No. CS-132, Quality Assurance and Construction Management Services for Third Street Light Rail Transit Project, Phase I, to Sverdrup Civil Inc., for an amount not to exceed \$16,000,000 and a term not to exceed five years, and authorized the Director of Transportation to execute said Agreement in a form to be approved by the City Attorney's Office, pending approval by the Civil Service Commission and the Board of Supervisors; now, therefore, be it

RESOLVED, That this Board of Supervisors approves the award of Contract No. CS-132, Quality Assurance and Construction Management Services for Third Street Light Rail Transit Project, Phase I, to Sverdrup Civil Inc., for an amount not to exceed \$16,000,000 and a term not to exceed five years, subject to the approval by the Civil Service Commission, and
