

1 [Consultant Contract for Third St. Light Rail Transit Project.]

3 **Resolution approving the award of Municipal Railway Contract No. CS-132, Quality**
4 **Assurance and Construction Management Services for Phase I of the Third St. Light**
5 **Rail Transit Project, to Sverdrup Civil Inc. for an amount not to exceed \$16,000,000 and**
6 **for a term not to exceed five years; placing \$12,381,055 on reserve.**

8 WHEREAS, On June 20, 2000, the Municipal Transportation Agency (MTA) Board of
9 Directors adopted Resolution No. 00-070, which authorized the Director of Transportation to
10 advertise a Request for Proposals (RFP), select the most qualified proposer, and negotiate a
11 contract with that proposer to procure quality assurance and construction management services
12 at a cost not to exceed \$16,000,000, and for a term not to exceed five years; and,

13 WHEREAS, The Municipal Transportation Agency issued an RFP on August 21, 2000
14 and received seven proposals in response to the RFP on September 29, 2000; and,

15 WHEREAS, On July 3, 2001, pursuant to Resolution No. 01-080, the MTA Board of
16 Directors approved the award of Contract No. CS-132, Quality Assurance and Construction
17 Management Services for Third Street Light Rail Transit Project, Phase I, to Sverdrup Civil
18 Inc., for an amount not to exceed \$16,000,000 and a term not to exceed five years, and
19 authorized the Director of Transportation to execute said Agreement in a form to be approved
20 by the City Attorney's Office, pending approval by the Civil Service Commission and the
21 Board of Supervisors; now, therefore, be it

22 RESOLVED, That this Board of Supervisors approves the award of Contract No. CS-
23 132, Quality Assurance and Construction Management Services for Third Street Light Rail
24 Transit Project, Phase I, to Sverdrup Civil Inc., for an amount not to exceed \$16,000,000 and
25 a term not to exceed five years, subject to the approval by the Civil Service Commission, and

1 authorizes the Director of Transportation to execute said Agreement in a form approved by
2 the City Attorney's Office and substantially as contained in the document on file with the Clerk
3 of the Board of Supervisors in File No. 011272, which is hereby declared to be a part of this
4 resolution as if set forth fully herein; and, be it

5 FURTHER RESOLVED, That funds in the amount of \$12,381,055 are hereby placed
6 on reserve, pending submission of more information for the project in budget years
7 subsequent to fiscal year 2001-2002, to be released by the Finance Committee.




