Proposed Grant Project Summary: The requested CARES Act funds and AIP grant funds will provide for the noise insulation of properties to minimize the impact of aircraft noise in neighboring communities. To be considered, the properties must be located within the minimum thresholds (defined as 65 decibels Community Noise Equivalent Level) on the Noise Exposure Map or be part of contiguous neighborhoods partially within this area and meet other eligibility requirements. Scope of work includes outreach and analysis to confirm each property's eligibility, acoustical testing, and design and construction of noise insulation improvements.

The Federal Aviation Administration will administer the CARES Act funds. In FFY 2020 the Airport anticipates receiving both – AIP grant funds and CARES Act supplemental discretionary grant funds for the Noise Insulation Program.  As a requirement for receiving CARES Act funds, the Airport must continue to employ through December 31, 2020, at least 90% of the number of individuals employed (after making adjustments for retirements or voluntary employee separations) as of March 27, 2020, the date of enactment of the CARES Act.
