3 **Ordinance authorizing settlement of the lawsuit filed by Joseph Marengo against the**  
4 **City and County of San Francisco for \$35,001; the lawsuit was filed on October 2, 2023,**  
5 **in San Francisco Superior Court, Case No. CGC-23-609444; entitled Joseph Marengo**  
6 **vs. City and County of San Francisco, et al.; the lawsuit involves an employment**  
7 **dispute.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Joseph Marengo vs. City and County  
12 of San Francisco, et al., San Francisco Superior Court, Case No. CGC-23-609444 by the  
13 payment of \$35,001. The lawsuit involves an employment dispute.

14 Section 2. The above-named action was filed in San Francisco Superior Court on  
15 October 2, 2023, and the following parties were named in the lawsuit: Plaintiff Joseph  
16 Marengo, defendant City and County of San Francisco.
