

1 [Master Lease Amendment - U.S. Navy - Treasure Island South Waterfront]

3 **Resolution approving the Twenty-Seventh Amendment to the Treasure Island South**  
4 **Waterfront Master Lease between the Treasure Island Development Authority and the**  
5 **U.S. Navy to extend the term.**

7 WHEREAS, The Treasure Island Development Authority ("Authority") and the United  
8 States of America, acting by and through the Department of the Navy (the "Navy"), entered  
9 into a master lease dated September 4, 1998, for the Authority to use and sublease certain  
10 land and structures on former Naval Station Treasure Island (as amended from time to time,  
11 the "South Waterfront Master Lease") at no rent; and,

12 WHEREAS, The South Waterfront Master Lease enables the Authority to sublease  
13 portions of the master leased area for interim uses and generate revenues to support the  
14 interim operation of Treasure Island and the future redevelopment of the former Naval Station  
15 Treasure Island; and,

16 WHEREAS, The term of the South Waterfront Master Lease expires on November 30,  
17 2011; and,

18 WHEREAS, The Authority wishes to extend the term of such lease for a period of one  
19 (1) year beginning on December 1, 2011 and ending on November 30, 2012, unless sooner  
20 terminated in accordance with the terms and conditions of the Master Lease; and,

21 WHEREAS, The Navy concurs with such amendment and the amendment has been  
22 approved by the Authority Board of Directors at its May 11, 2011 meeting; and,

23 WHEREAS, The Authority's Bylaws require that the Authority obtain Board of  
24 Supervisors approval of any agreements having a term in excess of ten (10) years or  
25 anticipated revenues of \$1,000,000 or more; and,

1           WHEREAS, Because the cumulative term of the South Waterfront Master Lease  
2 exceeds ten (10) years, the Authority is requesting that the Board of Supervisors approve the  
3 Twenty-Seventh Amendment to extend the term of such lease for a period of one (1) year  
4 beginning on December 1, 2011 and ending on November 30, 2012, unless sooner  
5 terminated in accordance with the terms and conditions of the Master Lease; now, therefore,  
6 be it

7           RESOLVED, That the Board of Supervisors hereby approves and authorizes the  
8 Director of Island Operations of the Authority or her designee to execute and enter into the  
9 Twenty-Seventh Amendment to the South Waterfront Master Lease in substantially the form  
10 filed with the Clerk of the Board of Supervisors in File No. 110680, and any additions,  
11 amendments or other modifications to such Twenty-Seventh Amendment (including, without  
12 limitation, its exhibits) that the Director of Island Operations of the Authority or her designee  
13 determines, in consultation with the City Attorney, are in the best interests of the Authority and  
14 do not otherwise materially increase the obligations or liabilities of the Authority, and are  
15 necessary or advisable to effectuate the purpose and intent of this resolution.


