By Supervisor Ammiano, that letter be sent to the Bay Area Water Transit Blue Ribbon Committee requesting information on the extent to which alternative fuel ferries have been analyzed for use on the Bay and urging the Blue Ribbon Committee to undertake a feasibility study of alternative fuel ferries and fueling stations for expanded ferry service on the Bay.

By Supervisor Leno, that letters of inquiry be sent to various departments, concerning compliance with the Mayor's Executive Order of March 25, 1998 with respect to equating domestic partners to spouses as follows:

- (1) Department of Agriculture, Weights and Measures: who may apply for booths at the Farmers Market.
- (2) Department of Building Inspection: continuing permit process by surviving domestic partner of deceased applicant.
- (3) Adult Probation: non-discrimination on the basis of domestic partners with respect to visitation rights in jails and access to after care programs.
- (4) Commission on Aging: food programs for the elderly and transportation programs for seniors.
- (5) Animal Care and Control Department: who may retrieve an impounded animal from the Animal Care and Control facility.
- (6) Planning Department: continuing the permit process by the surviving domestic partner of deceased applicant; applying for liquor licenses, and obtaining business permits.
- (7) Civil Service Commission: grievance disputes.
- (8) Controller: clarification of the definition of children and family.
- (9) Ethics Department: conflict of interest forms.
- (10) Fire Department: who may join the credit union and scheduling for married/partnered personnel.
- (11) Department of Public Health: creation of birth certificates.
- (12) Juvenile Probation: who may retrieve a child upon release; who is allowed/required to attend family counseling; participation with respect to log cabin ranch.
- (13) Chief Medical Examiner-Coroner: death certificates and disposition of remains.
- (14) Department of Parking and Traffic: retrieval of impounded cars; applying for neighborhood parking permits; any parking exemptions which apply to spouses.
- (15) Police Department Academy: domestic partner domestic violence training and any program participation which involves spouses.
- (16) Port Authority: family fares or discounts.
- (17) Public Guardian: disposition of property, care of invalids and recognition in a will.
- (18) Public Defender: information disclosure (other than attorney/client privilege).
- (19) Sheriff: visitation and after care programs.
- (20) Department of Elections: who may retrieve an absentee ballot for their spouse/domestic partner.
- (21) Recreation and Park Department: Camp Mather, family rates for use of facilities.
- (22) Public Utilities Commission: policy on use of cabins at Hetch Hetchy; who can pay water bills; family use fees at watershed properties.

By Supervisor Newsom, that letter be sent to the Director, Department of Telecommunications and Information Services requesting the following information: (1) the total costs for the establishment and maintenance of World Wide Web sites for every department within the City and County of San Francisco; (2) a reasonable time line for the execution of web sites for every department.

By Supervisor Newsom, that letter be sent to the Golden Gate National Recreation Area, Attn: Leonard McKenzie and Tracey Fortman inquiring whether it would be possible to remove the metal cyclone fence running along Marina Boulevard on the North side of the street near Steiner Street and what steps would need to be taken to accomplish this and whether the City can assist in any way.
