9 WHEREAS, The purpose of the grant is to provide supplies and handouts during
10 National Night Out community events on August 2, 2011; and

11 WHEREAS, The grant does not include any provision for indirect costs; and

12 WHEREAS, The San Francisco Police Department is seeking retroactive approval
13 because it did not receive the grant award until July 1, 2011; and

14 WHEREAS, This grant does not create any new positions, and will not require an
15 amendment to the Annual Salary Ordinance; now therefore be it


16 **RESOLVED** The City and County of San Francisco is authorized to retroactively accept
17 and expend a grant from the Target Corporation in the amount of \$3,000; and be it

18 **FURTHER RESOLVED**, That the Board of Supervisors hereby waives inclusion of
19 indirect costs in the grant budget; and be it

20 **FURTHER RESOLVED**, That the Chief of Police, or his designee, is authorized to
21 accept and expend these funds on behalf of the City and County of San Francisco.
