3 **Resolution approving, retroactively, an Amendment to the CIBER, Inc. contract to**  
4 **reduce the contract amount to \$4,995,120.**

6 WHEREAS, In April 2008, the City and County of San Francisco, Department of  
7 Human Resources (DHR) awarded CIBER, Inc. (CIBER) a \$13,563,250.30 - 29-month  
8 contract for implementation services to integrate the City's human resources and payroll  
9 functions; and,

10 WHEREAS, To remain within the project's budget DHR has decided to complete the  
11 project with in-house resources; and,

12 WHEREAS, In order to complete the project in a timely manner, DHR is submitting a  
13 companion resolution to increase the project's FTE count by ten City resources; and will  
14 continue to use selected subcontractors for project implementation; and,

15 WHEREAS, Pending Board of Supervisors approval of the Amendment, the City's  
16 Project Manager used her authority under the contract to suspend CIBER's work on the  
17 project effective September 3, 2009; and,

18 WHEREAS, DHR has negotiated an agreement with CIBER to reduce the contract  
19 from \$13,563,250.30 to \$4,995,120; and,

20 WHEREAS, The Statement of Work has correspondingly been reduced to include  
21 acceptance of accomplished deliverables and the continued service of CIBER subcontractors  
22 through September 15, 2009; and,

23 WHEREAS, The Amendment includes a mutual release of all remaining obligations  
24 and claims under the existing contract and statements of work; therefore, be it

1 RESOLVED, That the Board of Supervisors hereby approves, retroactively, a contract  
2 Amendment with CIBER, Inc. reducing the contract amount to \$4,995,120 based on the terms  
3 and conditions of the Amendment on file with the Clerk of the Board of Supervisors in File No.  
4 091139.
