3 **Motion amending the Rule of Order 5.1, establishing size, membership and jurisdiction**
4 **of the Budget and Finance Committee.**

6 MOVED, That the Board of Supervisors of the City and County of San Francisco does
7 hereby amend Rule 5.1 to read as follows:

8

9 5.1 The Budget and Finance Committee shall be referred appropriation ordinances,
10 and measures concerning bond issues, taxes, fees and other revenue
11 measures, redevelopment and real estate. The Budget and Finance Committee
12 shall also be referred the annual appropriation and annual salary ordinances.
13 The Budget and Finance Committee shall hold a public hearing on the Mayor's
14 budget instructions to City Departments for each annual City budget after the
15 instructions are released.

17 The Budget and Finance Committee shall be comprised of three full-time
18 members except that beginning on March 1 of each year the Committee shall be
19 comprised of five members and shall remain a Committee of five members until
20 the Board of Supervisors adopts the annual appropriation and salary
21 ordinances. Following the adoption of the annual appropriation and salary
22 ordinances by the Board of Supervisors, the committee will be reduced to the
23 three full-time members.

~~Beginning on March 1 of each year, and until the Board of Supervisors adopts the annual salary and appropriation ordinances, there shall be a subcommittee of the Budget and Finance Committee consisting of three members. Unless otherwise designated by the President, the members of the subcommittee shall be the full-time members of the Budget and Finance Committee. The subcommittee may consider any matters assigned to the Budget and Finance Committee except the annual appropriation and salary ordinances or the Mayor's budget instructions.~~
