Resolution authorizing the Office of Contract Administration to enter into the Third Amendment of the contract agreement between the City and County of San Francisco and InterVision Systems Technologies, Inc., a Technology Marketplace, Tier 1B Specialist contractor, to increase the contract limit from \$15,499,000 to \$30,000,000 for the period of October 1, 2014, through September 30, 2018.

WHEREAS, The Office of Contract Administration, by competitive bidding, developed the Technology Marketplace procurement method for the purchase of products and services related to Information Technology; and

WHEREAS, InterVision Systems Technologies, Inc. is one of the vendors who is part of the Technology Marketplace, Tier1B Specialists; and

WHEREAS, The original contract with InterVision Systems Technologies, Inc. dated October 1, 2014, has a term of three years through September 30, 2017, with options to extend the term through September 30, 2019, and has an original contract amount of \$12,000,000; and

WHEREAS, The Board of Supervisors approved the original contract on October 1, 2014 by Resolution No. 362-14; and

WHEREAS, The Board of Supervisors approved the First Amendment to the contract on June 14, 2016 by Resolution 238-16 to increase the contract amount from \$12,000,000 to \$15,000,000; and

WHEREAS, The Office of Contract Administration approved the Second Amendment to the contract on November 30, 2016 to increase the contract amount from \$15,000,000 to \$15,499,000; and

WHEREAS, The Office of Contract Administration estimates that the money projected to be spent with InterVision Systems Technologies, Inc. could reach the contract's limit in the reasonably near future; and

WHEREAS, Charter, Section 9.118(b) "Contract and Lease Limitations," requires the Board of Supervisors to approve any contract estimated to exceed \$10,000,000 in expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be it

RESOLVED, That the Board of Supervisors authorizes the Purchaser and the Director of the Office of Contract Administration to enter into the Third Amendment to the contract with InterVision Systems Technologies, Inc. in substantially the form attached to increase the contract limit from \$15,499,000 to \$30,000,000; and, be it

FURTHER RESOLVED, That within thirty (30) days of the Third Amendment being fully executed by all parties, the Office of Contract Administration shall provide the final Third Amendment to the Clerk of the Board for inclusion into the official file.
